- Public Sector Budget Deficit Forecast: £175bn
 - Government Procurement Spend: £175bn
 - Budget Cuts Promised by All
 - Procurement Cuts vs Public Sector Jobs and Services

DOES PUBLIC SECTOR PROCUREMENT MATTER?

- £175bn pa
- 40% of Public Sector Costs
- £3,000 per Adult and Child pa
- £250,000 per person into the 'Public Sector Purchasing Pot'
- 65% Non-Central Government
- 45% Common Categories
 - Goods, Services and Utilities

Effective Management is Essential

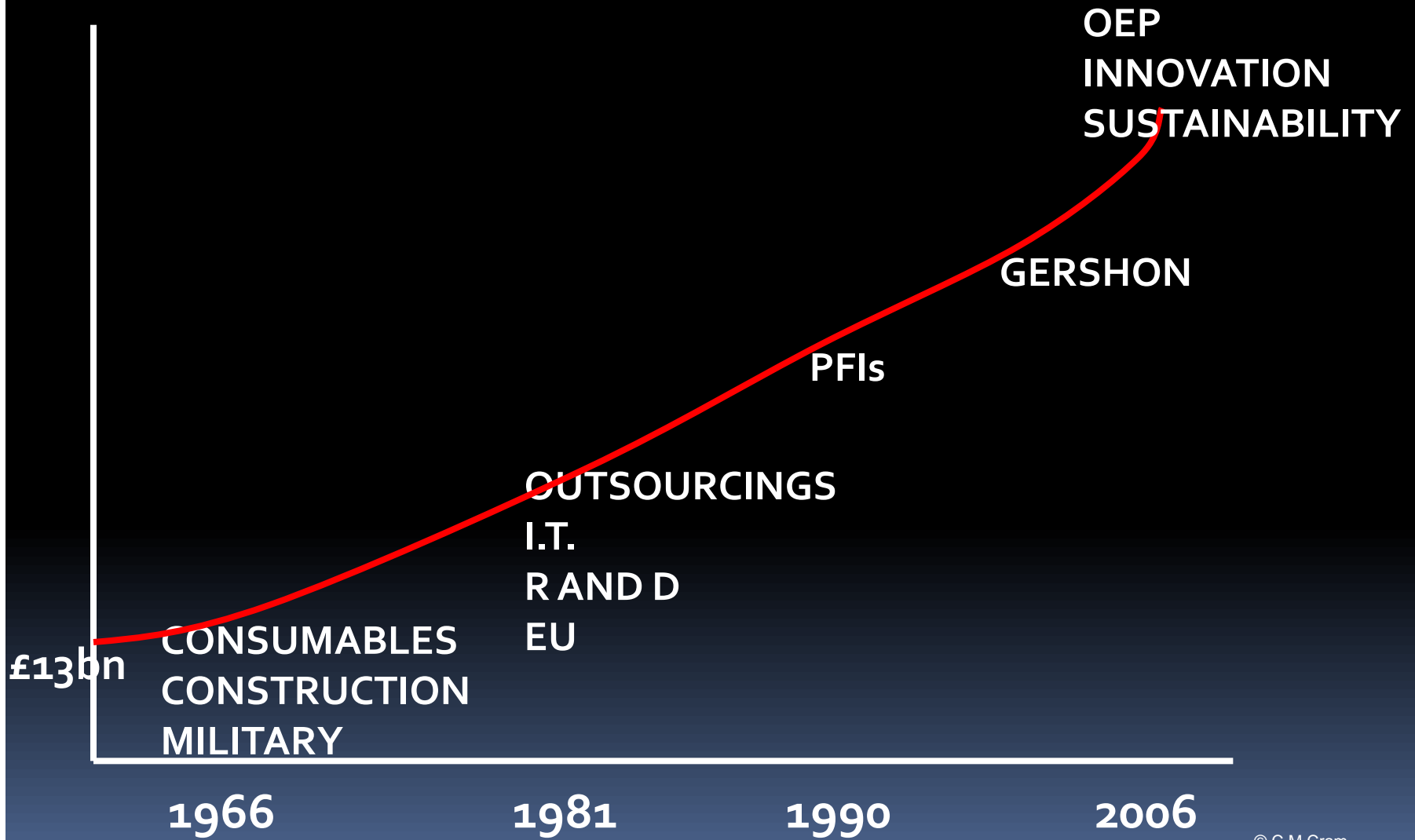
SO HOW WELL IS PUBLIC SECTOR PROCUREMENT MANAGED?

- Many (40,000?) Small to Medium Procurement Organisations/Units

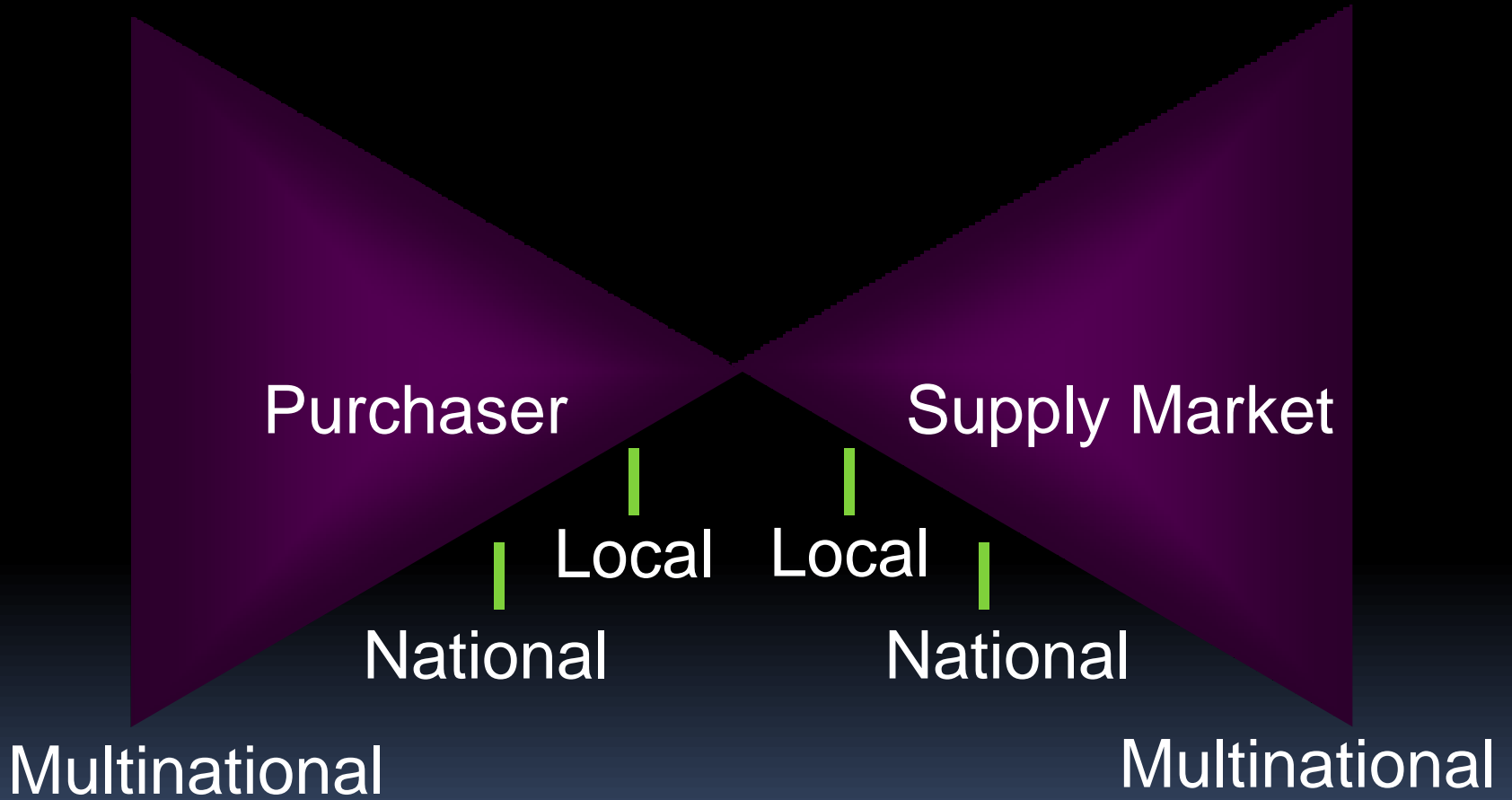

HOW 'LEAN' IS PUBLIC SECTOR PROCUREMENT?

Public Sector Organisations Create Unnecessary Costs For Suppliers

- Indiscipline
- Different Procedures/Contract Ts and Cs
- Complexity – e.g. Tender Procedures
- Multiplicity of Tenders
- Multiplicity of 'Duplicate' Contracts and Contract Managers
- Multiplicity of Attempts to Manage Supply Chains
- Inconsistency
- Specifications

Furniture	30%
FM/Outsourcing/Major Contracts	Up to 35%
Laboratory Consumables	Up to 90%
Laboratory/Medical Equipment	20%?
IT	5 – 80%
Construction	5 – 25%
Excellent Construction Management	5 – 15%
Social Care	10%
Legal Services	10%
Good Contracts Management	5 – 35%
